### **SBCA Annual Meeting**

### **Spring Projects**

Although we didn't meet our goal to have all the maintenance projects completed before summer arrived, we did get most of them done despite the many rain delays. As of this writing the following projects have been completed:

- 1. <u>Roof Replacement</u> The roof on the 9-12 Brassie Ct. building was replaced.
- 2. <u>Staining Project</u>

The four (4) buildings along the river were completed. Staining will continue next summer with the staining of two (2) or three (3) additional buildings.

- 3. <u>Street Repairs</u> Four areas were patched this summer on both courts.
- 4. <u>Decks</u> All decks were washed to remove algae and dirt.
- <u>Exterior Window Washing</u> The first of two window washings was completed during the week of July 26<sup>th</sup>.
- 6. <u>Sprinkler Repairs</u> Sprinkler heads were replaced/ repaired.

### Parking Regulations - Update

Although the illegal parking seems to have been eliminated except for a few incidents, the Board would like to remind you that if you see a car parked illegally, please call the Hotline at 630-415-1174 to report it. Don't call the towing company. They will only tow cars when an authorized member of the Board calls them or when their driver observes an illegally parked car between 2:00 a.m. and 4:00 a.m.
