# **2011 Maintenance Projects**

It continues to be the goal of the Board to have all of this year's projects done this spring or early summer. This will allow our residents to enjoy their decks throughout the summer without being interrupted by construction crews. Listed below are this year's projects.

# **Roof Replacement**

It has been determined that the roof on 1-4 Mashie Court was in most need of replacement this year. Crews for Stec Roofing will start to replace the roof soon. Weather permitting, this project should be completed within two weeks.

# **Staining Project**

The remaining three buildings on Brassie Court will be stained this year (1-4, 5-8, and 17-20.) The buildings will be power washed first. An email to homeowners in these buildings will be sent prior to the beginning of the project.

### **Street Repairs**

The Board will soon determine if any areas need to be patched this year. All residents will be informed prior to any work being done.

### **Sprinkler System Repairs**

Sprinkler system repairs will be handled by Elite Landscaping this year. The system will be turned on and checked sometime in May.

# **Exterior Window Cleaning**

Exterior windows will be washed two times again this year. The project will be

scheduled so that it will not conflict with the staining and roof projects.

### **Spring Walkaround**

Members of the Board will be walking around the units and grounds in the next couple of weeks to do a quick inspection. This is done on an annual basis. We will make arrangements to fix those items that are the Associations responsibility and send letters notifying owners of items they must fix, such as garage door panels.

### **Annual SBCA Garage Sale**

This year's annual garage sale is scheduled for May 19-21, 2011. Signs will be posted on Double Eagle Drive and ads will be placed in the local newspaper and the internet garage sale sites.
