#### **SBCA Annual Meeting**

The SBCA Annual Meeting has been scheduled for Thursday, **September 24, 2015** at the Woodridge Park District Community Center, 2600 Center Drive, beginning at 7:00 p.m. The meeting will be held in the first floor meeting room. The building is fully handicapped accessible.

Please complete and return your Proxy ballot to the Association if you are unable to attend the meeting on the 24<sup>th</sup> of September.

## **Spring Walk Around**

The Spring Walk Around was held in June. Letters were sent to homeowners notifying them of items they need to repair/fix. In addition, the Board addressed a number of items that are its responsibility.

#### **Spring and Summer Projects – Status Report**

The Board is pleased to report that except for a few items the majority of the work planned for this summer has been completed. As of this writing the following projects have been completed:

#### • Exterior Window Washing:

The first of two window washings for this year has been completed.

#### • **Sprinkler Repairs**:

The irrigation system was turned on after a number of repairs were made to the sprinkler heads and system. Ongoing repairs continue to be made as needed.

#### • Replacement of Rotten Wood:

Rotten deck railing parts and trim on some units is being replaced.

#### • Staining – Touchup, etc:

Crews have begun to sand and prime all deck railings in preparation for a new coat of stain or paint in September.

#### • Down Spouts:

Down spouts have been extended or repaired in many areas.

#### • Deck Power Washing:

A light power washing of all decks is still planned for this summer/fall.

#### • Streets:

The Board has been discussing a plan to do a major street replacement; more information will be available at the Annual Meeting on Thursday, September 24, 2015.

#### **Trees and Shrubs:**

The Board has continued to fertilize and treat the trees and shrubs in our community.

• The Ash trees are receiving treatments to help fight the emerald ash borer that has destroyed hundreds of trees in the suburbs, Chicago, and Woodridge.

## • Plant/Shrub Replacements:

Our annual planting of new and replacement shrubs will begin after Labor Day.

#### What is the Board Working on Now?

The Board is currently working on the following items:

- Beginning to gather information for the 2016 SBCA budget.
- Preparing for the SBCA Annual Meeting on Thursday, September 24, 2015.
- Discussing major repairs that the Association will face in the future.
- Seek proposal and determine when to remove seven (7) trees that have died.

#### **Fall Dryer Vent and Chimney Cleaning**

The Association will coordinate another dryer vent/chimney cleaning day this fall. A survey asking if you wish to participate will be emailed to you toward early September. The price we secure will depend upon how many positive responses we receive.

#### **How the SBCA Voice Mail Works**

The SBCA Voice Mail is answered by volunteers from the SBCA Board. Each month a board member answers the voice mails and either directs the inquiry to the appropriate board member or personally answers the inquiry. Each board member establishes his/her own routine for checking the voice mails depending upon their own schedule. Therefore, if you leave a message at 1:00 p.m., and the voice mail was checked at 9:00 a.m., you may not receive a call back until the next day. Sometimes the voice mails are checked every two days.

If you have an emergency or concern that may be Association related and you haven't had a call back, knock on one of our doors. Just remember that we will try out best to promptly return your calls regarding Association business.

## **SBCA Homeowners Insurance FYI**

Board Member Carol Redell is responsible for securing proof of homeowner's insurance (HO3 or better) as required (see the *Rules & Regulations under Insurance*.) Letters are mailed to all homeowners approximately thirty days before the policy expiration date. You may drop off the Declaration Page at Carol's home at 1 Brassie Court or mail it to Seven Bridges Courts Association at 27 Mashie Court, Woodridge, IL 60517.

Another option is to have your insurance agent list Seven Bridges Courts Association as an "Interested Party" on your insurance policy. They will automatically forward the Declaration Page to the Association via email at sbcaresidents@comcast.net or by U.S. mail. #### **Pet Owners**

Residents have requested that we remind pet owners (especially dog owners) to take their pets off our property to take care of their "business." The Village of Woodridge has ordinances regarding picking up after your pet, but liquid, which can't be picked up damages the grass creating clumps and dead spots.

The islands on both our courts as well as other common areas are showing the damage caused by the frequent pet visits.

Due to the damage caused by frequent visits to areas, the Association may need to spend money to reseed/resod these areas to restore them to their original condition.

Also, pet waste must not be left outside in front of the units either in plastic bags or bags of any size laying on the ground or hanging on our landscape plants. It is unsightly, and is prohibited by the SBCA bylaws. So please take responsibility for your pet and don't let them soil the plants and grass on our property.

Lastly, please keep your pet on a leash. There is a Leash Law in Woodridge.

#### **Speed Limit on Brassie and Mashie Courts**

The speed limit on our courts is <u>10 MPH.</u> We have several small children residing on both Brassie and Mashie Courts. Observing the required speed limit will insure their safety.
