DECKS: Some helpful hints to avoid future problems

Here are a few helpful hints to prolong the life of your deck.

- Limit the outside storage on and around your decks. Excessive accumulation of stuff will become an eyesore that your neighbor does not need to look at.
- Store your firewood in your garage, not on your deck. The wood attracts moisture and bugs that may result in damage to your deck.
- Relocate (move around) any flower pots on your deck to avoid moisture buildup and make sure your pots don't drain directly on to the deck.
- Keep your deck clean and sweep it off once in awhile.

Owner Responsibility for Wasps and Bees

We have had a lot of questions lately about bees and wasps. Spraying for wasps and bees is the responsibility of each homeowner and not the Association. However, the Association will continue to monitor the carpenter bees and ants that have taken up residence in some of the handrails on a few decks in our community. This is being done to prevent damage to the deck wood, and hopefully, eliminating the need to have any wood replaced.

Spring and Summer Projects – Status Report

The Board is pleased to report that except for a few small items the majority of the work planned for this summer has been completed. As of this writing the following projects have been completed:

Roof Replacement:

The roof on 1-4 Mashie Court was replaced.

Staining Project:

The last three buildings on Brassie Court were stained (1-4, 6-8, and 17-20.)

Street Repairs:

A total of seven areas were patched on both courts.

Exterior Window Washing:

The first of two window washings for this year has been completed.

Sprinkler Repairs:

The irrigation system was turned on after a number of repairs were made to the system.

Spring and Summer Projects – Status Report Power Washing:

Areas on four buildings on Mashie Court were power washed to eliminate mold that was accumulating on the sides of the buildings.

Chimney Caps:

One of the severe storms that ran through Woodridge this summer loosened a number of chimney caps and knocked one to the street. These caps were repaired and remounted.

Flower Bed Fertilization:

For the first time ever, all flower beds were fertilized this summer.

Trees and Shrubs:

The Board has continued to fertilize and treat the trees and shrubs in our community.

The Ash trees are receiving treatments to help fight the emerald ash borer that has destroyed hundreds of trees in the suburbs, Chicago, and Woodridge.

The dead pine needles under our trees were recently removed to help fight the spores that were recirculating back up the trees and causing damage.

Roof Repairs:

A few necessary roof repairs were made on one or two buildings that have not been reroofed yet.

What is the Board Working on Now?

The Board is currently working on the following items:

- Securing quotes for minor paver repairs.
- Reviewing the Rules and Guidelines Manual for areas that need updating i.e., use of email rather than mailboxes.
- Gathering information for the 2012 SBCA budget.
- Preparing for the SBCA Annual Meeting in September.

It is unsightly, and is prohibited by the SBCA bylaws. So please take responsibility for your pet and don't let them soil the plants and grass on our property.
